BACKGROUND TO PRODUCER PRICES

INTRODUCTION

This publication contains price information from UK manufacturers and importers. All data is now based on the Standard Industrial Classification SIC (2007).

PRODUCER PRICES IMPLEMENTATION OF SIC 2007

Producer prices (PPI) implemented the change onto the Standard Industrial Classification of All Economic Activities 2007 (UKSIC 2007) in November 2010. The most significant change to PPI output prices is the reclassification of recovered secondary raw materials (i.e. recycling) and publishing out of manufacturing and into the service sector. The SIC 2007 project has included fundamental changes made to the classification of the PPI Trade surveys, import price indices (IPI) and export price indices (EPI). The collection of these is now on an SIC basis, a switch for the Standard International Trade Classification (SITC) and Combined Nomenclature (CN) previously used. As a result PPI trade surveys are now compliant with Eurostat Short Term Statistics Regulation. This change of classification used will have a direct impact on the framework structure of PPI input prices, as IPI's account for a large proportion of total input price sales.

WHAT ARE PRODUCER PRICES?

Producer Price Indices (PPIs) are a series of economic indicators that measure the price movement of goods bought and sold by UK manufacturers. It is a base weighted index working on the basket of goods concept. A wide range of representative products are selected and the prices of these goods collected each month. The movement in these prices are weighted to reflect the relative importance of the products in a chosen year (known as the base year) currently 2005. These are then aggregated for various sectors of industry to provide the published indices in the monitor.

The input PPIs (table 3) measure changes in the price of materials and fuel bought by manufacturers for processing. The output PPIs (table 4) indicate changes in the prices manufacturers charge for goods destined for the UK market as they leave the factory net of VAT and after discounts.

What is MM22?

This publication is produced monthly and provides price movement data at all manufacturing, aggregated industry and product group level. It consists of data supplied from individual UK manufacturers, importers and exporters.

What's Included?

The Producer Price Indices are calculated from the price movements of around 6,750 closely defined materials and products purchased (including imports) and manufactured by UK industry. This price data is converted into a basic set of price indices from which broad series are built up. Products destined for sale in the UK are grouped in accordance with the Standard Industrial Classification 2007 with weighting patterns based on overall purchases and sales by manufacturers within those groupings. The indices published in this monitor are widely used by business in price escalation clauses in contracts and for monitoring price movements in the products they trade.

Special Indices

ONS may for a charge, make up a special index for you and provide regular monthly updates. Each case is considered against the resources required to produce and maintain the series requested.

Data Formats

Data can be downloaded in either plain text file or Navidata[®] 3.1 formats. Navidata[®] 3.1 is free software developed specifically for analysing and using economic time series data - it enables you to create tables and charts, and export in CSV (comma or tab separated) formats which are compatible with your PC's spreadsheet software Download Navidata® 3.1 software and a sample dataset.

NOTES

Reading the data

These notes should help you interpret the information in the following tables.

What are Net Sector Output Indices? The weighting patterns used to calculate net sector output indices exclude transactions between companies classified to the same sector e.g. manufacturing sector or manufacturing excluding food, drink, tobacco and petroleum. For example, for Net Sector Output purposes, the value of an electronic component manufacturer's sales to a car manufacturer would be excluded from the weighting patterns used to derive final index values (thereby reflecting the value of sales to only those purchasers outside the manufacturing sector).

What are Gross Sector Output Indices?

This series is found in tables 2 and 4 represents the price movement of goods sold within the UK by companies classified to manufacturing as defined by SIC (2007). Weights are calculated on a gross basis i.e. all transactions are included in deriving the weighting patterns, including sales within the same industry.

What are Input/Output Group Input Indices?

This series represents the price movement of materials and fuels purchased by UK manufacturers and is found in table 3. The I/O group input series all include purchases of materials and fuel including those between manufacturers classified to the same sector of industry (e.g. one chemical manufacturer to another).

How are Export Prices calculated?

The Export Price Indices (EPIs) use broadly the same methodology as the PPI. A range of representative products are selected and the prices of these goods collected each month from established exporters within specified 6 digit SIC (2007) codes. The movement in these prices are weighted to reflect the relative importance of these products and aggregated to provide the published indices in table 6. The series are calculated on a base year of 2005=100.

What about VAT and Excise Duties?

All indices are compiled exclusive of Value Added Tax. Excise duties (on cigarettes, tobacco, alcoholic liquor and hydrocarbon oils) are included except where specified otherwise.

What about Provisional Data?

Indices for the latest two months are provisional and flagged with a 'p' marker due to the level of imputation present for items where the latest prices are not available. The latest five months are subject to revisions in light of (a) late and revised contributor data and (b) revisions to seasonal adjustment factors which are re-estimated every month.

What about Revisions?

Occasionally, information is received that produces a change in an index value that has already been published as firm. Where the change is significant, index values are recalculated and annotated with an 'r' marker. What about Price Changes?

The monthly index data relates to an average calculation for the month. The effect of price changes occurring part way through the period will only be reflected in an index in the following month's publication.

No Data?

You will see that various symbols are used throughout this publication to provide meaning to the gaps in the data or where the quality of the index values is reduced. There are a number of these and the following key will provide an explanation:

- **B** These index values are considered less reliable mainly due to the lack of market coverage.
- F Indices labelled F are based on relatively few quotes and in the long term should not be relied upon for contractual purposes.
- " These values have been suppressed because the index would risk disclosure of individual price movements.


Output prices: summary

In the year to April, movements in output prices for UK manufactured products were as follows:

- The output price index for home sales of manufactured products rose 5.3 per cent, compared with 5.6 per cent last month.
- The output price index excluding food, beverages, tobacco and petroleum rose 3.4 per cent.
- The output price index excluding excise duty rose 5.5 per cent.

Between March and April:

- The output price index for home sales of manufactured products rose 0.8 per cent, reflecting widespread increases across most product groups, in particular tobacco and alcohol.
- Changes in excise duty are estimated to have added 0.3 per cent to the overall output index in April.


Input prices: summary

In the year to April 2011, movements in input prices of materials and fuels purchased by the UK manufacturing industry were as follows:

- The total input price index rose by 17.6 per cent.
- The input price index for the manufacturing industry excluding the food, beverages tobacco and petroleum industries rose 12.2 per cent.

Between March and April:

- The total input price index rose 2.6 per cent, mainly reflecting a price rise in crude oil.
- Seasonally adjusted, the input price index for the manufacturing industry excluding the food, beverages tobacco and petroleum industries rose 1.7 per cent.
- The price of imported materials as a whole (including crude oil) rose 2.7 per cent.

Revisions (Tables 8R and 9R)

For this bulletin Tables 8R and 9R highlight revisions to movements in price indices previously published in last month's Statistical Bulletin. These are mainly caused by changes to the most recent estimates, as more price quotes are received, and revisions to seasonal adjustment factors, which are re-estimated every month.











Summary of statistics for producer prices – April 2011

Output prices

The overall output price index rose 5.3 per cent in the year to April 2011, compared with a rise of 5.6 per cent in the year to March. The index rose 0.8 per cent between March and April, mainly reflecting price rises in tobacco and alcohol products (including duty), petroleum products (including duty) and clothing, textile and leather products. Between March and April 2010 the index rose 1.0 per cent.

Tobacco and alcohol product (including duty) prices rose 2.6 per cent between March and April and rose by 5.5 per cent in the year to April. This is the largest monthly rise since April 2010 when the index also rose 2.6 per cent and was last higher in April 2000 (2.8 per cent). The monthly rise was due to a 5.4 per cent increase in tobacco products and a 1.1 per cent increase in alcoholic beverages. This largely reflects the increases in excise duty on tobacco products (23 March) and alcohol products (28 March).

Petroleum product (including duty) prices rose 1.3 per cent between March and April and rose by 14.9 per cent in the year to April. The monthly rise was mainly due to increases of 1.5 per cent in the price of diesel and gas oil and 0.9 per cent in unleaded petrol. This includes the effect of a decrease in excise duty on petroleum products (23 March).

Clothing, textile and leather product prices rose 1.3 per cent between March and April and rose by 4.6 per cent in the year to April. This monthly rise is the largest since records began (February 1996) and is the highest annual rate since records began (January 1997). The monthly rise was mainly due to a 1.9 per cent increase in clothing and a 1.1 per cent increase in textile prices.

Apart from a slight fall in computer, electrical and optical product prices, all other product groups recorded price rises in the month of April.

Output price index excluding food, beverages, tobacco and petroleum

The output price index for manufactured products excluding food, beverages, tobacco and petroleum rose 3.4 per cent in the year to April, compared with a rise of 3.1 per cent in the year to March. This index is not affected by changes in excise duty. The index rose 0.6 per cent between March and April compared with a rise of 0.4 per cent between March and April 2010.

Output price index excluding excise duty

The output price index for all manufactured products excluding excise duty is shown in Table 3 of the Statistical Bulletin. This index rose 5.5 per cent in the year to April, unchanged from March. The index excluding excise duty rose 0.7 per cent between March and April, the same as the rise between March and April 2010.



Input prices

The overall input index rose 17.6 per cent in the year to April, compared with a rise of 14.8 per cent in the year to March (Table 5). This is the highest annual rate since September 2008 when the index rose 24.2 per cent.

The input index for all manufacturing rose 2.6 per cent between March and April compared with a rise of 0.1 per cent between March and April 2010. The monthly rise in the input index between March and April mainly reflected a rise in the price of crude oil, and to a lesser extent, rises in imported chemicals, other imported parts and equipment and imported metals.

Crude oil prices rose 7.1 per cent between March and April and rose 37.7 per cent in the year to April. This is the highest annual rate since May 2010 when the index rose 38.7 per cent.

Imported chemical prices rose 1.5 per cent between March and April and rose 11.2 per cent in the year to April. The monthly rise was due to increases across a range of imported chemicals, most notably a rise in the price of plastics in primary forms.

Other imported parts and equipment prices rose 1.0 per cent between March and April and rose 4.3 per cent in the year to April. This is the highest annual rate since July 2010 when the index rose 5.3 per cent. The monthly rise was due to widespread increases across a range of imported parts and equipment, most notably a 1.3 per cent rise in the price of imported electronic components and boards.

Apart from a slight fall in home produced food, all other product groups recorded price rises in the month of April.

Input price index excluding the food, beverages, tobacco and petroleum industries

The index for materials and fuels purchased by manufacturing industry excluding the food, beverages, tobacco and petroleum industries rose 1.7 per cent in seasonally adjusted terms between March and April. The unadjusted index rose 12.2 per cent in the year to April, compared with a rise of 10.3 per cent in the year to March (Table 5). This is the highest annual rate since December 2008, when the index rose 13.2 per cent.

Background Notes

Key issues to this specific release

1. The output PPI for April 2011 was affected by Budget increases in taxation of tobacco (coming into effect from 23 March) and alcoholic drinks (coming into effect from 29 March) and a Budget decrease in taxation of petroleum products (coming into effect from 23 March). If passed on in full, these changes in excise duty (on petroleum, tobacco and alcohol) are estimated to have added 0.3 per cent to the overall output index in April 2011.

Implementation of SIC 2007 in ONS: Update on PPIs and SPPIs

4. Producer Prices has implemented the change to the Standard Industrial Classification 2007 (SIC 2007). The most significant change to PPI output prices involves the reclassification of 'recovered secondary raw materials' and 'publishing'. These are no longer classified in the manufacturing sector, but are classified under services. In addition to this, a new SIC division, 'repair, installation and maintenance of machinery and equipment' has been created. Under SIC 2003 these activities were classified within the output of manufacturing, but as part of the specific industries where this activity took place.



5. Fundamental changes have been made to the classification of the PPI Trade surveys, Import Price indices (IPI) and Export Price Indices (EPI). As part of the reclassification project the classification of these trade surveys have become compliant with Eurostat's Short Term Statistics Regulation. The collection of IPI and EPI will now be on an SIC basis, a switch from the Standard International Trade Classification (SITC) and Combined Nomenclature (CN) previously used. PPI input prices are heavily dependant on IPI.

Relevance to users

- 6. Index numbers shown in the main text of this bulletin are on a net sector basis. The index for any sector relates only to transactions between that sector and other sectors, sales and purchases within sectors are excluded. However, the more detailed figures shown in tables 4 and 6 are on a gross basis; that is, intra industry sales and purchases are included in each of these indices.
- 7. Indices relate to average prices for a month. The full effect of a price change occurring part way through any month will only be reflected in the following month's index.
- 8. All index numbers exclude VAT. Excise duty (on cigarettes, manufactured tobacco, alcoholic liquor and petroleum products) are included, except where labelled otherwise. Since PPIs exclude VAT, they are not affected by the increase in the standard rate of VAT to 20 per cent from 4 January 2011.
- 9. The detailed input indices of prices of materials and fuels purchased by industry (Table 6) do not include the climate change levy (CCL). This is because each industry can, in practice, pay its own rate for the various forms of energy, depending on the various negotiated discounts and exemptions that apply.



Common pitfalls in interpreting series

- 10. Expectations of accuracy and reliability in sample surveys are often too high. Revisions and sampling variability are inevitable consequences of the trade between timeliness, accuracy and the burden on respondents. Details of sampling variability are included elsewhere in this bulletin.
- 11. Very few statistical revisions arise as a result of 'errors' in the popular sense of the word. All estimates, by definition, are subject to statistical 'error' but, in this context, the word refers to the uncertainty in any process or calculation that uses sampling, estimation or modelling. Most revisions reflect either the adoption of new statistical techniques or the incorporation of new information which allows the statistical error of previous estimates to be reduced. Only rarely are there avoidable 'errors' such as human or system failures, and such mistakes are made quite clear when they are discovered and corrected.

Accuracy

12. Figures for the latest two months are provisional and the latest five months are subject to revisions in light of (a) late and revised respondent data and (b), for the seasonally adjusted series, revisions to seasonal adjustment factors which are re-estimated every month. A routine seasonal adjustment review is normally conducted in the autumn annually. There are no planned methodological changes in the next 12 months.

Revisions

- 13. Revisions to data provide one indication of the reliability of key indicators. The tables below show summary information on the size and direction of the revisions which have been made to the data covering a five year period. A statistical test has been applied to the average revision to find out if it is statistically significantly different from zero. An asterisk (*) shows that the test is significant.
- 14. The table below presents a summary of the differences between the first estimates published between April 2005 and March 2010 and the estimates published 12 months later.
