Farm Incomes in the United Kingdom, published on the 23 March 1995, provides detailed information on the structure of the United Kingdom agricultural industry.

The tenth volume, in an annual series, gives detailed analyses of the developments in the income, assets and liabilities of the agricultural industry at the farm level and in aggregate. Detailed economic results, based on the Farm Business Survey (Farm Accounts Scheme in Scotland) are shown by country, farm type, business size and tenure as well as estimates of the gross margins for a range of crop and livestock enterprises in England and Wales. In most tables the years covered are 1993 and 1994.

For the first time a special study of farmer's capital investment was carried out on the same sample of farms for the Farm Business Surveys for the years 1990/91 -

1992/93. The details are summarised in the report and the objective of the Capital Investment Survey was to provide more detailed information about the level and pattern of investment in Agriculture at farm level for England and Wales.

The report gives the results of a survey of the ownership There is one new table - table 2.16 on the 'ethnic of ordinary shares in listed companies in the United Kingdom, carried out on behalf of the CSO by Fulcrum Research Ltd. The survey's aim was to discover how the value of UK listed ordinary shares, some £762 billion at the time of the survey, was distributed between categories of beneficial owner on 31 December 1994.

The survey showed that:

- UK institutional shareholders held 59 per cent of shares by value, amounting to £446 billion. Within this, the largest component was held by pension funds - £212 billion.
- Between 1963 and 1989 the proportion of shares owned by individuals fell continuously. Since then their share has been fairly steady at around 20 per cent.
- For the second year running, overseas holders held 16.3 per cent of shares.

This report was published in October 1995 and refers to academic staff in Higher Education Institutions. It contains a large number of graphs showing how the age distributions of staff in each subject area has changed since 1989. The work which lead to the report was carried out in order to check whether or not there was a need to put some money into an initiative that would move the age distribution of lecturers towards the younger age groups. The report concluded that no action need be taken but that HEFCE should ensure that relevant national data is published periodically to provide information for managers of higher education institutions. The form and structure of that information is at present under discussion.

Control of Immigration: Statistics United Kingdom, First Half 1995

The regular half yearly Home Office Bulletin on the control of immigration was published on 19 October 1995. This bulletin contains summary information on acceptances for settlement in the United Kingdom; entry clearance applications in the Indian sub-continent; admissions to the UK and extensions of stay in selected categories; and enforcement action.

A selection of the main points of the bulletin are:

- Acceptances for settlement in the United Kingdom in the 12 months ending 30 June 1995 provisionally totalled 54,800 about 500 fewer than in the previous 12 months.
- A fall of 3,000 in acceptances of recognised refugees and exceptional leave cases more than offset rises in UK ancestry and employment cases, children and wives.
- 37,900 applications for asylum, excluding dependants,, were received, almost 50 per cent more than in the previous 12 months. Of the 25,100 total decisions made, 4 per cent were to recognise the applicant as a refugee and grant asylum.
- Enforcement actions was initiated against 14,700 persons, 30% more than in the previous 12 months, and 5,000 persons left the United Kingdom as a result of such action.

Health Expectancy

OPCS has recently published a study of the development of health expectancy indicators for use in monitoring public health, and for comparing the health states of different populations.

Health expectancy uniquely combines mortality and morbidity into a single index. Health expectancy is the generic term, and specific health expectancy indicators can, in principle, be constructed for any, usually chronic, health conditions of interest. Most commonly it has been used to refer to disability-free expectancy, which is the focus of this study.

Researchers in OPCS, together with experts from the Universities of Kent and Leicester, have reviewed the main methods of calculating health expectancy as an indicator of the nation's health. The study was funded by the Department of Health.

The study also looks as examples of a range of applications of the indicator and draws conclusions about suitable methodologies for the future. It discusses the policy applications and background to the scientific concern with health expectancy, and the application of indicators to the UK, the study sets out the practical requirements for adopting health expectancy as an indicator for the UK.

Turnover of social workers increased. Senior social worker entrants increased 9% (less than last year) and leavers increased 9% (greater than last year). Main Grade entrants increased 10% and leavers by 20%, both less than last year.

The number of staff studying for the Diploma in Social Work decreased 15%, although those undertaking Post-qualifying studies increased 4%. Staff undertaking Social Work Management courses increased 63%, although other areas decreased including Social Work Practice (21%), General Management (40%) and Other (30%).

Community Care Bulletin 1994

There were 17,960 places in residential homes for older people as at March 1994. Forty nine per cent of this provision was in the private and voluntary sectors as compared to 35 per cent in 1980. This is largely due to the expansion in the private sector which accounted for 26 per cent of total provision in 1994. The number of places in day centres for older people was 8,455 in 1994 which has more than doubled since 1980 where the number of places was 3,600.

These are some of the findings in the Community Care Bulletin 1994 which is published today. This provides statistics on community care services for adults, with information from the Social Work, Health and Housing fields.

Other findings include:-

There was a 3 per cent increase in the number of people receiving a home help service between 1993 and 1994. The 1994 figure reached almost 91,000. This number shows an increase of 50 per cent on the 1980 figure. Over the same period the number of home helps rose by 10 per

cent, resulting in an increase in the average number of clients per home help from 6 in 1980 to 8.5 in 1994. In the year to March 1994 there were 2.3 million meals-on-wheels served.

The shift away from hospital care and towards more care in the community is further demonstrated by the fall in the average number of NHS geriatric long-stay beds from 7,853 in 1993 to 7,337 in 1994, while there was an increase in the number of places in Registered Nursing Homes from 17,012 to 17,646 in 1994. This pattern was also reflected in the average number of NHS staffed beds for the speciality of Mental Health problems or Psychogeriatric specialty, where there was a fall from 12,300 in 1993 to 11,300 in 1994.

The level of sheltered housing provision continued to increase, with 37,200 sheltered housing dwelling in 1994 compared to 35,800 in 1993.

For the financial year 1993-94 total identifiable gross expenditure on Social Work Services for older people was £302 million. Expenditure on physically disabled people, people with learning disabilities and people with mental health problems totalled £145 million.

Statistical Bulletin On Child Protection Management Information 1993-94: November 1995

Between 1 April 1993 and 31 March 1994, some 7,500 children in Scotland were referred to Social Work Departments as being in need of protection, according to a Statistical Bulletin published today by the Social Work Services Group of The Scottish Office. Of these 53 per cent were girls.

The Bulletin is the outcome of a completely new system of management information and represents the first overview of key activities in child protection.

The other main findings are:-

- There were 4,187 referrals in Scotland during 1993-94 where the source of referral was known. Twenty one per cent of referrals were investigated following information from the child involved, and a further 30 per cent from parents and other relatives.
- The age groups of children involved in Child Protection cases were evenly spread. 32 per cent were 0-

4, 36 per cent were 5-10, 30 per cent were 11-15 and 2 per cent were 16+.

- Children referred to Social Work Departments are protected by interim measures. These measures once taken to alleviate the risk to each child. Non-statutory Social Work Support was provided to 32 per cent of children investigated.
- 2,963 referrals went to case conference in Scotland. Case conferences evaluate whether or not the child requires an inter-agency protection plan to eliminate unacceptable levels of risk. 80 per cent of police, teachers and school doctors attended case conferences to which they were invited.
- 1,880 children were placed on the Child Protection register in Scotland 45 per cent for Physical Injury, 25 per cent for Sexual Abuse, 19 per cent for Physical Neglect, 9 per cent for Emotional Abuse and 2 per cent for Failure to Thrive. Registers are part of the arrangements for the care and protection of the child through an inter-agency plan.
- The household composition of registered children were 41 per cent both birth parents, 24 per cent single mother, 11 per cent birth mother and partner and 6 per cent birth mother and stepfather.
- In 70 per cent of case parents were suspected of being the main perpetrator 40 per cent birth fathers and 30 per cent birth mothers.
- In cases of sexual abuse 97 per cent involved a male perpetrator: in 41 per cent he was the birth father; in 23 per cent another relative; and din 18 per cent the birth mother's partner.
- Of children whose registration was reviewed, 41 per cent were de-registered: in most cases (57 per cent) the home situation was judged to have improved.
- In Scotland there were 2,666 children on child protection registered as at 31 March 1994.

New Figures Published on Offenders Working in the community

In the two years 1992 and 1993, Scotland's courts dispensed a total of some 1.5 million hours of Community

Service to offenders; in 1993 more than 5,600 offenders were required to do unpaid work in the community.

Since its inception in 1979 Community Service has increasingly been seen by the courts as a viable alternative to custodial sentences for offenders. Recently, Community Service order have been imposed on numbers equal to a third of those sent to prison, whereas in 1979 seven times more offenders were imprisoned than required to do Community Service.

These figures are published today in a Scottish Office Social Work Services Group publication, the statistical bulletin 'Community Service Bulletin 1992 and 1993'.

The main type of activity undertaken by offenders was manual work with 41% involved in painting and decorating and a further 21% involved in gardening. The main recipients of those services during 1992 and 1993 were the elderly and frail accounting for 43% of Community Service placements. A further 29% were helping community and neighbourhood charities. Fifty nine per cent of all placements involved direct contact with the beneficiaries of the work undertaken.

The main crimes resulting in Community Service orders for the offenders responsible during the period 1992 and 1993 were crimes of dishonesty. This refers to housekeeping (both domestic and commercial premises), theft by opening lockfast places, theft of motor vehicles, fraud, forgery and embezzlement.

Where the requirements of a Community Service order are not met by the offender, the order may be revoked. Such a breach usually results from an offender failing to attend the Community Service placement. Fourteen percent of all orders terminating in 1992 and 1993 were breached, 55% of which were due to a failure to attend. Of those offenders who breached their order, half were subsequently sentenced to custody.

In 1993 15,743 offenders were considered for Community Service by the courts. This figure is an increase of over 30% on 1991 figures. Thirty per cent of those referred were ordered to do Community Service. A further 6% were required to do Community Service as a requirement of a probation order. The use of this latter type of disposal has risen ten fold over the past ten years, doubling over the two years to 1994.

1994 Figures Published On Children's Hearings System

There were 42,924 referrals to Reporters in 1994 - a record number and up 6 per cent on the 1993 figure. This ended the recent downward trend between 1991 and 1993. The number of children to whom these referrals related in 1994 was 25,232 and represented 24.0 children per thousand of the population under 16 - just below rates reached in 1991 and 1992.

These and other statistics relating to the Children's Hearings system are included in the statistical bulletin 'Referrals of Children to Reporters and Children's Hearings 1994' published by The Scottish Office today.

Between 1993 and 1994 the number of referrals on nonoffence grounds decreased marginally whilst the number of offence referrals has increased. Over the last decade the number of non-

offence referrals has more than doubled; offence referrals have increased less dramatically over the same period, by nine per cent.

The most common reason for referral on non-offence grounds for both boys and girls was where the child was a victim of an offence. There were just under 7,000 referrals submitted on this ground in 1994; around 3,000 for boys and 4,000 for girls. Of these referrals, the most likely offence committed against boys was assault or ill-treatment (37% of cases). Where the victim was a girl, the offence was most likely to have been a sex offence (43% of cases).

12.9 children per 1,000 population aged under sixteen were referred for offences in 1994; a marginal increase on 1993 but lower than in previous years. Rates varied between 9,9 and 16.0 in different local authority areas. Boys committed 83 per cent of offences referred to Reporters in 1994; the main offenders were fifteen-year-old boys, with 99.1 per 1,000 population being referred to alleged offences. There were nearly five times as many offence referrals for boys as there were for girls.

Three in ten offence referrals were further referred to a hearing by the Reporter compared to nearly four out of ten non-offence referrals. The trend towards supervision of children within the community as opposed to residential supervision continued in 1994. Eighty-seven per cent of children under supervision at 30 June 1994 were not in

institutions but at home with parents/guardians or staying with foster parents or other relatives.

Of the 1,400 children in residential supervision at 30 June, two thirds were boys. Sixty per cent of boys under residential supervision had been referred for offences compared to only 30 per cent of girls; girls were mainly put under residential supervision on care and protection grounds.

Although the effects of the errors in the original volume were pervasive, the changes in the numbers were very small - generally the final digit changes by +/-1. The analysis presented in the text of the volume is, therefore, only affected to a minor extent. It is not intended to issue a revised text, but the corrected main tables, A1 to G, have been reissued.

Seaborne Trade Statistics of the United Kingdom

The 1994 edition of this publication is now available, presenting a wide range of statistics on seaborne trade with different countries and for the major commodity

groups. Some additional tables for 1993 have been included, to bridge the tap left by the non-appearance of a 1993 edition. This was primarily a result of the amount of work needed to amend the means of transport information provided on Intrastat.

The publication includes an article Estimating transport data from Intrastat, which sets out many of the difficulties. Intrastat collects information from exporters or importers of goods. The quality of the means of transport data collected from them is poor, as they have no great interest in the details of the transport process. For example, a sizeable share of the UK's trade with continental EC countries was reported as crossing the UK national border by road, which is inherently unlikely. The Department of Transport has reallocated this traffic, usually to sea transport. The article described the adjustment process and shows modal splits before and after reallocation (HMSO ISBN 0 11 551751 0, price £24).
