









# Wage and Employment Dynamics Research Development Workshops

## Background

The <u>Wage and Employment Dynamics</u> project (WED) an 'enriched' version of the Annual Survey of Hours and Earnings (<u>ASHE</u>), as well as linking this to the Census 2011 (<u>ASHE-Census2011</u>). These datasets are now available for researchers to use through the Office for National Statistics Secure Research Service (<u>SRS</u>). Future datasets from the same project will include links from ASHE to HMRC datasets (employment and self-employed earnings, and migration data).

WED was funded by the <u>ESRC</u> through Administrative Data Research UK (<u>ADR UK</u>). ESRC is keen to maximise its investment in these datasets, particularly in policy-relevant research. It is running Fellowship and PhD programmes targeted at use of the ADR UK datasets; there are also ongoing research funding opportunities (such as the <u>Secondary Data Analysis Initiative</u> (SDAI) and the ESRC policy fellowships – UKRI), which would be suitable vehicles to seek funding for research on these datasets.

## Workshop aims

The aim of the workshops is to bring academics and policymakers together to explore potential research areas of interest using the new WED datasets. Through exercises and facilitated discussions, the aim is to stimulate research ideas and identify areas of common interest between attendees. The discussion groups will also seek to identify potential funding routes for different types of research project.

# Who is behind the workshop?

The workshop is a collaboration between WED, Economic Statistics Centre of Excellence (ESCoE: <a href="www.escoe.ac.uk">www.escoe.ac.uk</a>), ADR UK and the Office for National Statistics, with support from the Department of Work and Pensions, the Low Pay Commission and the Bank of England.

## Who should attend

We expect the workshop to be attended by a roughly equal mix of researchers (in academia, government, or the third or private sectors) and 'policymakers' (including government analysts in policy areas). Specifically, this workshop should be of interest to

- Researchers who have (or would like to develop) an interest in applied labour market analysis in the UK
- Researchers familiar with the ASHE or Census data looking to explore new research areas
- Academics looking for potential PhD projects
- Policymakers with specific questions not currently (or obviously) addressed by existing research

#### **Activities**

The workshop will be mainly activity based. The provisional schedule is:

- 30 minutes: introductions over refreshments
- 45 minutes: presentations by WED, ESRC; introductions to the policy departments
- 1 hour 45 minutes: facilitated discussions and activities, seeking specific actions to develop networks, research plans and/or funding proposals.
- 30 minutes: sharing and review of outcomes; identification of further actions to support those outcomes
- 45 minutes-1 hour: closing refreshments
